2. Consequences of treatment as a Professional Client

As a consequence of the above categorization as a Professional Client, you will lose certain of the protections afforded to Ordinary Clients under SCA, including those described below:

2.1. Communicating with clients: Where we issue a communication or financial promotion (if any), we are required to ensure that it is fair, clear and not misleading to the kind of recipient to whom it is communicated and contain sufficient detail about the nature and risks of Investments to allow the recipient to make an informed assessment. These obligations will continue to apply even though we treat you as a Professional Client but, in making our assessments as to what is appropriate and propotionate to include, we will be entitled to take in to account your expertise and understanding. This means that such communications and promotions need not satisfy a number of conditions designed to ensure that they they are understandable to an Ordinary Client and may contain a lesser degree of explanation or of warning as to risks that would be the case with an Ordinary Client.

We may also agree to provide you with less information about the nature and risk profile of financial instruments that we offer to you. By categorizing you as a Professional Client, we may be able to send to you financial promotions in circumstances where we would otherwise not be able to do so.

- 2.2. Suitablility and appropriateness: We will be entitled to assume that you have the necessary level of experience and knowledge to understand the risks involved in relation to the product or investment services offered / demanded when making any assessment as to the suitablility or appropriateness of a service we are providing to you, and as such you will not benefit from the protections afforded under the relevant conduct of business rules. For any investment services, we are also entitled to assume that you are able to financially bear any investment risks consistent with your investment objectives. In addition, as a Professional Client, we are not required to provide you with a suitablity statement or report.
- 2.3. Reporting Obligation: We shall have less extensive reporting obligations to you as a Professional Client in relation to execution of orders and investment services. We shall be entitled to exclude from the periodic reports that we send certain information which would be required for an Ordinary Client.
- 2.4. Client order handling: As a Professional Client, we shall not be specifically obliged to inform you of any material difficulty which impacts on our ability to properly carry out orders.

3. Action Required

Please acknowledge your acceptance of, and agreement to be legally bound by, the contents of this notice by signing below.

Your signature will constitute your agreement to be categorized as a Professional Client and confirmation that you have had sufficient time to consider the implications of such a categorization and that you are aware of the consequences of losing protections that would otherwise be afforded to you as an Ordinary Client.

Nothwithstanding anything to the contrary in this Notice of Treatment or any other agreement between you and us (including any provision which purports to prevail over the General Dealing Terms), no provision (whether in the General Dealing Terms, this Notice of Treatment or in any other agreement between you and us) shall operate so as to remove, exclude, restrict or waive our obligations.

Any capitalized terms used but not defined in this Notice of Treatment shall have the meaning given to them in the General Terms & Conditions governing investment services entered between you and HBZ UAE.
